AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of South Whidbey School District No. 206 from September 1, 2011 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll
- Enrollment
- Associated Student Body
- Procurement

Our opinion on the District's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the District's financial statements.

Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal program, which is listed in the Federal Summary section of the financial statement and single audit report.

INFORMATION ABOUT THE DISTRICT

South Whidbey School District No. 206 provides public school services to approximately 1,350 students in kindergarten through 12th grade. The District's service area covers 60 square miles of Island County, including the city of Langley and the southern end of Whidbey Island. The District has one high school, one middle school, an elementary school and a parent partnership program school.

An elected, five-member Board of Directors governs the District. The Board appoints the Superintendent who is responsible for the District's day-to-day operations as well as its 110 certificated and 60 classified employees. For fiscal year 2012, 2013 and 2014, the District had general fund expenditures of \$15,380,252, \$14,483,595 and \$15,191,087, respectively.
